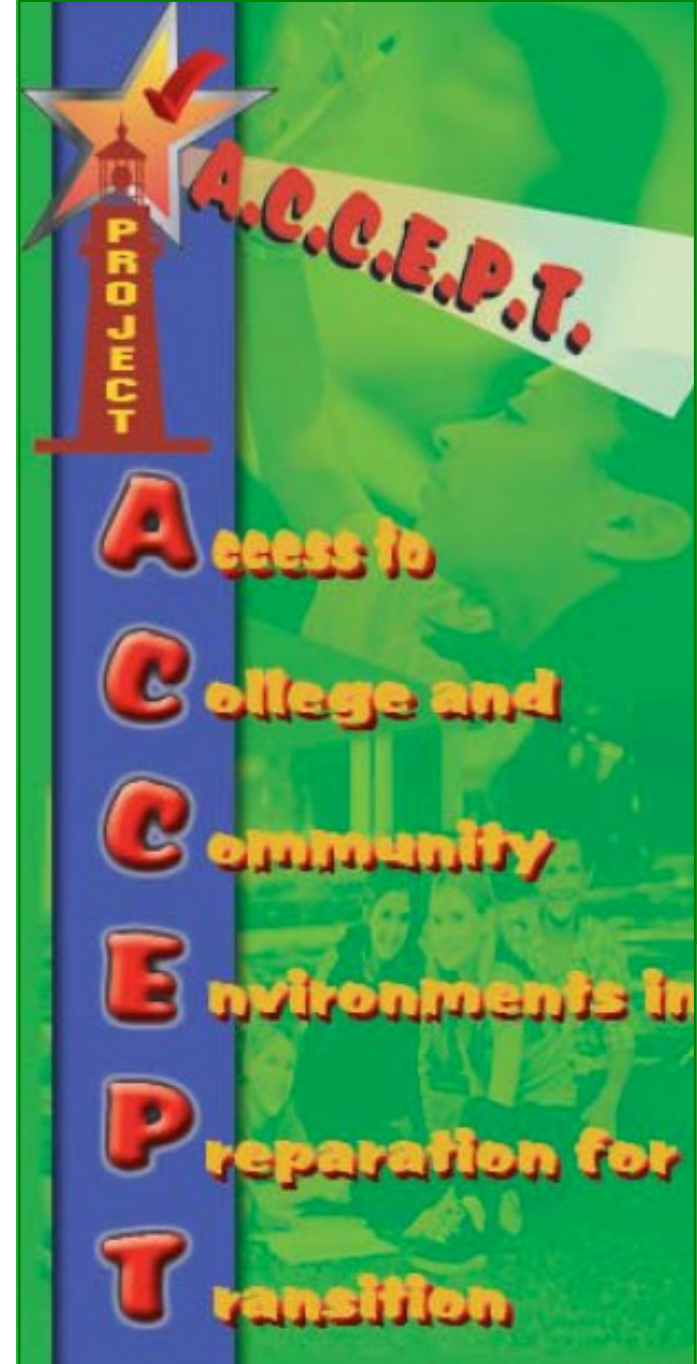

## What is Project ACCEPT

Project A.C.C.E.P.T. (Access to College and Community Environments in Preparation for Transition) provides students with developmental disabilities an opportunity to interact with same age peers in a college environment.

### Eligibility Criteria

- ⇒ Be 18-22 years of age.
- ⇒ Be capable of changing classrooms independently.
- ⇒ Be able to participate in small group activities.
- ⇒ Be able to follow simple directions.
- ⇒ Be able to remain seated in chair without supervision and/or assistance for a one-hour period.
- ⇒ Does not require extensive supervision for acute or chronic conditions, such as special diets or seizures.
- ⇒ Displays a level of social maturity conducive to a college environment.
- ⇒ Be able to maintain personal self-care and hygiene appropriately.
